

ASSOCIATED RESEARCH 90TH ANNIVERSARY GIVEAWAY

OFFICIAL TERMS AND CONDITIONS

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

By completing and submitting the Associated Research 90th Anniversary survey, eligible participants may receive one (1) entry into the Giveaway described below. Open only where lawful. Void where prohibited.

1) SPONSOR

The sponsor of this giveaway (the "Giveaway") is Ikonix USA LLC, 28105 N. Keith Drive, Lake Forest, Illinois 60045 ("Sponsor").

2) GIVEAWAY PERIOD

The Giveaway begins on April 1, 2026 and ends on December 31, 2026 (the "Giveaway Period"). Entries submitted before or after the Giveaway Period are not eligible.

3) ELIGIBILITY

The Giveaway is open only to individuals who, at the time of entry: (a) are at least eighteen (18) years old or the age of majority in their jurisdiction, whichever is higher; (b) are acting in a business capacity within the electronics test and measurement industry; and (c) are not employees, officers, or directors of Sponsor, its affiliates, subsidiaries, advertising or promotion agencies, or any entity involved in the administration of the Giveaway, and are not immediate family members (spouse, parent, child, sibling, and their respective spouses) or household members of the foregoing.

A survey must be fully completed to qualify for entry. Upon Sponsor's receipt of a completed eligible survey submission, the participant will receive one (1) entry into the Giveaway.
